

MUGALICIOUS 2022

Terms & Conditions

1. Mugalicious (the promotion) commences at 10.00am AEST on Friday 1 July 2022 and concludes at 11.59pm on Sunday 31 July 2022 (Promotion Period).
2. The promotion is promoted by Central Launceston Marketing Inc. (the Promoter) Level 1, 63 – 65 Cameron Street in Launceston, Tasmania.
3. All entrants will be subject to, and will need to adhere to, the Terms & Conditions as set by the Promoter and any future Terms & Conditions amended.

The Prize

4. The Prize consists of:
 - a.
